How should candidates get onto the PA Ballot? Ballot Access Concurrence Thursday, April 20 at 7 p.m. Diane Duntley's home at 204 Greenview Court

LWVIC Ballot Access Committee will be presenting material related to how parties get on the ballot and will be asking LWVIC members if they concur with the Centre County position which is as follows:

1. The PA Election Code should be made available for downloading on the PA Government Web site.

2. A minor party candidate is to submit the same number of signatures on their petition as required for a major party candidate.

3. When an objection is filed to the nomination of a candidate, in regard to signature irregularities, all candidates for that office will have their petitions reviewed by the appropriate election board.

LEAGUE LINGO

CONCURRENCE - Substantial member agreement preferably reached through group discussion based on information presented by a study committee or through other methods of member response. Members are asked to concur, or agree with, a statement rather than to answer a question as with consensus. A concurrence statement may be a position held by another League or a decision statement recommended by a League board or study committee. Statement must be approved or rejected as written.

CONSENSUS - Substantial member agreement preferably reached through group discussion. Consensus is the sense of the group rather than a majority opinion. Discussion is based on information prepared by a study committee and is guided by consensus questions.

CONSENSUS QUESTIONS - Specific questions prepared by a study committee to stimulate interaction, focus discussion and facilitate conclusions by the group. Questions vary in style from open-ended to multiple choice. Questions are approved by the appropriate League board. Paper Trail of Ballots to Continue in Indiana County

Indiana County will be one of the few counties in Pennsylvania to have a **voter verifiable paper audit trail (VVPAT)** in upcoming elections. Many voter concerns were expressed in local public hearings about challenges to Direct Recording Electronic voting machines (DRE's) data. The county commissioners chose to continue the current optical scan voting system — with the addition of optical scanners for precincts so that voters can review their ballots for under or over votes (thereby meeting Help America Vote Act requirements). Automark DRE machines will be purchased by the fall election to accommodate handicap accessibility thereby meeting this HAVA requirement. Temporary DRE machines will be available for the primary but those with a handicap may wish to continue having someone assist them for this election to ensure a paper record of their ballot. As counties across Pennsylvania deal with challenges to outcomes from varying choices of DRE's in the upcoming elections, the leadership of Indiana County may be proven to have chosen very wisely.





Air Quality Committee: Progress Report: School Bus Idling Policies

Members of the Air Quality Committee met with Mr. Michael Travis, Transportation/Safety Supervisor of the Indiana Area School District recently as follow up to our school bus idling policy phone survey. We chose to start with Indiana Area School District because it had no formal idling policy and because several of the committee members had children in this school district giving us "interested citizen" credibility.

Why are we interested in Stop Idling Policies? Indiana County ranks at the 80th percentile in the nation (622nd out of 3,109) for diesel soot emissions. * This is high for a rural county. Children are more at risk for health problems from diesel emissions. We save money when we run engines for shorter periods of time, both in terms of engine wear and tear and fuel consumption.

Information learned included:

- The school district contracts with Krise Bus Company for equipment and drivers. It is part of the ARIN fuel consortium, which will be switching to the new low sulphur diesel fuel "later this year."
- The Indiana Area School Bus fleet has an average age of 5 years. They require the company to replace 10% of the buses each year.
- All buses acquired after 2007 will be clean diesel

buses as required by law. At this rate, all buses will be clean burning engines by 2017.

• Newer buses drive the longer routes.

The bus queuing area was changed at the Junior High School to eliminate idling near the air intake.

We explained our interest in a "Stop Idling" campaign. Mr. Travis was very amenable to considering the health concerns, but was also clearly very interested in the financial savings arising from a "Stop Idling Bus" policy. He also seemed to like the idea of some positive publicity about a "Stop Idling" campaign. We agreed to mutually support each other with information exchange regarding anti-idling policies, location of training tapes for bus drivers, and watch for grant opportunities to retrofit older buses with clean air technologies. We offered to help write grants if any appeared, to present the benefits of a stop idling policy to the school board, and to help with a "stop idling" publicity campaign.

We left believing our meeting was very cordial and productive. We'll keep you posted on progress.
