PRIMARY VOTERS GUIDE

The LWVIC will be publishing a voters guide for



the primary election on May 15 on its website. The voters guide will contain a list of candidates for school board in every school district in Indiana County. That is a total of 45 school board candidates. We are asking every candidate to respond to 4 questions about school issues. The replies will be on the website. You can see the questions on page 3.

In addition, we will have the tax referendum question for every school district in the county. Each will be slightly different depending on what option the district decided to submit to its residents. These referenda will determine how each district's taxes will be changed for the future, either shifting some of the taxes to an income tax, or

SOME THOUGHTS ON THIS PRIMARY

It is somewhat troubling that one of the most important issues in recent years will be resolved at what is the worst attended election in our election cycle. This year only local offices are on the ballot and in the primary there are very few contested elections. As a result, this election traditionally has extremely low voter turnout, usually well below 40%. that turnout is even worse when you consider that only about 50% of the eligible voters actually register to vote. The funding of our schools could be dramatically changed based on the votes of a very small percentage of school district residents.

The American Association of University Women Indiana Chapter (AAUW) and the League of Women Voters of Indiana County (LWVIC) invite all residents of the Indiana Area School District and those interested to attend **Candidates Night, Thursday**

May 10 beginning at 7 pm. The forum will be held at the Indiana Area Junior High Auditorium and will be broadcast live on radio stations WDAD and WCCS. This is a public event and there is no charge to attend. Please spread the news. The purpose of the forum is to educate citizens on the role of a school board member and to help Indiana area voters make informed decisions at the polls on May 15.

Primary Voters Guide:

All school board candidates received the opportunity to respond to these questions:

QUESTION 1: What in your background, training and experience qualifies you to be an effective school board member?

QUESTION 2: There is some concern that the No Child Left Behind focus on testing in reading, math, and science leaves scant time and attention for other impor-

tant goals of public education. What other areas do you think are important to emphasize so that our children grow to become healthy, responsible and productive citizens?

QUESTION 3: The PA School Boards Association Standards for Effective School Governance state that school boards govern by reviewing, revising and adopting board policy and delegate to the superintendent responsibility for implementation of board policy. Do you agree with this statement? Why, or why not?

QUESTION 4: Much of the burden of paying for public education falls on local taxpayers. Under Act 1 (2006) school districts may not raise their tax rates above a state-determined index without voter approval-- the "back-end" referendum. In what areas do you think funding could be decreased or even eliminated to balance the school budget and stay below the index?
