#### From the President

In June I had the good fortune to attend the biennial convention of the LWV United States in Atlanta, GA. Convention 2010 was inspirational and highly productive. Congressman John Lewis reminded us that change comes when groups like the League are not afraid to "get in the way." A panel of our past presidents (including Nancy Neuman from Selinsgrove PA) emphasized the



core values of League, careful study, consensus building and speaking with one voice. Secretary of Health and Human Services Kathleen Sebelius thanked us for the League's key role in achieving significant health care reform and reminded us that much more still needs to be done.

Delegates debated many of the critical issues facing citizens across the nation, including election reform, climate change, the need for redistricting reform, and health care reform, to name a few. Two new studies were adopted: The federal role in public education and the policy agenda on privatizing government services. Several new positions were adopted by concurrence including an arms control update, marriage equality for same gender couples, and use of the national popular vote compact. Also, many new resolutions were supported, including the UNANIMOUS passage of LWVUS support for safe drilling and mining for energy resources thanks in part to LWVPA's recent study on Marcellus Shale development. Fall promises a new start to implementing the program goals that LWVIC approved at its annual meeting in May. We'll put our calendar together at the retreat on August 10, at Reeger's. Also in August we'll be planning our displays for the Indiana Library as part of the Partner of the Month Program. We'll begin planning the Candidates Workshop that is scheduled for January 22, 2011. The committee will begin planning in the early fall. The League encourages those thinking about running for local government or school board to attend this semi annual event.

The workshop will help attendees understand the requirements for pursuing candidacy and the importance of the roles they will be called to perform.

The election cycle in 2011 includes about half of the positions on seven school boards, at least one supervi-

sor in each of 28 townships, and half of the positions on 14 borough councils, as well as some row offices at the county level.

## BUSY SUMMER FOR ENVIRON-MENTAL ISSUES COMMITTEE

Summer is traditionally a time of rest for the league, but this summer has been an exception. Sherene started off with a bang attending Convention 2010, where oil and gas development was a significant topic of caucuses and debate.

Here in Indiana, the Marcellus Shale development kept the Environmental Issues committee quite active. Susan McClure provided testimony at the PA House Finance Committee hearing on May 11 on the Marcellus Shale severance tax. Cindy and Clarice presented a slide show at the Federation of Democratic Women's summer meeting. LWVIC drafted a response to Representative Pyle's urging him to vote for a severance tax.

Aida, Cindy, Vera, and Pepita manned a booth at the Marcellus Shale Expo, which was co-

sponsored by Group Against Smog and Pollution (GASP), and provided information to truck drivers and industry representatives about the new anti

idling legislation. Mary Beth helped draft testimony for PALWV on the Department of Environmental Protection's proposed Chapter 78 Oil and Gas Well Regulations and accompanied Sue Broughton at the hearing.

has also offered assistance to the Commissioners to assemble a Task Force for the County to address the many impacts of Marcellus Shale on citizens, businesses, and local governments. To date there is no Task Force that includes representatives of a cross-section of the community, but the Committee will continue to pursue this.

can't commit to an on-going role.


