LWVUS to Update National Agriculture Policy Position

The LWVIC will be taking part in a national study to update the LWVUS position on agriculture policy. The current position was reached in 1990 after a two year nationwide study and consensus process. At that time our nation's farmers were in the midst of a major economic crisis, and issues relating to organic and alternative agriculture and farming's impact on the environment were becoming intensely debated by both the public and within the farming community. Since then, new issues have arisen, and the League needs to take these issues into account in order to enter the policy debate. The scope of the current study will thus be limited to two areas:

1. Technology issues including GMOs, pesticide and herbicide use, water pollution, aquifer depletion, antibiotics in livestock, and accurate food labeling; and, 2. Current agriculture finance issues including consolidation in the agriculture industry, crop subsidies, and the federal agriculture regulatory process.

Our local League is forming a committee to take part in the study process and prepare and present the background to our members at a local consensus meeting in March 2014. The national study committee will be writing the consensus questions, making suggestions for background reading, and tabulating the results of the local consensus meetings which are due April 4, 2014. The National Board will adopt those positions on which the local Leagues reach consensus and announce the results before the next LWVUS Convention in May 2014.

| SMART GROWTH PRINCIPLE | EXPLANATION |

| Compact Building Design | Control sprawl. It will reduce the need for more roads, sewers, water supply lines, etc. |
| Create range of housing opportunities and choices | Build for all citizens, e.g., low, middle, and high income, young and old. It will retain current people and attract new ones. |
| Create walkable neighborhoods | Reduce car/truck use when possible; Make it easy for adults and children to walk. |
| Encourage community and stakeholder collaboration | Open conversation reduces conflict and increases understanding of issues involved in land use. |
| Foster distinctive, attractive communities with strong sense of place | Keep what you like while increasing the tax base. Don't sacrifice the traditions and unique features of your municipality just for the sake of development. |
| Make development decisions predictable, fair and cost effective | Don't change the rules in the middle of the game. Consider all of your constituents. |
| Mix land uses | Place services and shopping places near homes, not miles away. |
| Preserve open space, farmland, natural beauty and critical environmental areas | Preserve the best parts of your municipality for your grandchildren and great grandchildren. |
| Provide a variety of transportation choices | Encourage as many types of transport as possible for people and business. Encourage business development near available transportation hubs. |
| Strengthen and direct development to- wards existing communities | Increase the value (your tax base) of current communities. Don't write them off. It will concentrate infrastructure needs. |


