Legislative Interview Questions

- 1. **Congressional and Legislative Redistricting** Will you actively support amending the Pennsylvania Constitution to require an independent commission comprised of individuals not currently employed by local, state, for federal government, to redistrict both legislative and congressional districts after the decennial census? Why or why not?
- 2. Judicial Selection Would you actively support an amendment to the Pennsylvania Constitution providing for a merit selection process for selecting statewide judges? Why or why not?
- 3. Education Funding Do you support legislation that would establish a realistic minimum level of expenditures for all school districts? How do you believe such an expenditure level

Legislative Interviews- Have Breakfast or Lunch with your State Legislators

Once a year, the League of Women Voters of Pennsylvania asks its local Leagues to interview the state legislators about state level issues. The State League formulates questions about several state issues on which it intends to lobby. The local League sets up the interviews during the month of February at times convenient to it and its state representatives and senators. The Local Leagues send reports on the interviews to the state office to help them determine their lobbying strategies. Here in Indiana we usually treat our legislators to breakfast or lunch and spend several hours discussing the LWVPA questions and occasionally some local issues as well.

All members are welcome at these meetings. We are presently making arrangements for the interviews and will be sending out email notices about the dates, times and place. We met with Dave Reed on January 25th. Our interview with Jeff Pyle was scheduled for February 1, but due to bad weather, we had to cancel it. If we can reschedule this interview, we will contact members as to the date, time and location. We will be meeting with Don White on Friday, February 29, 2008 at noon at Eat'n Park.

Plan to attend these meetings if you can. They are a pleasant way to remind our legislators that we are interested in state as well as local issues and are always very informative.

PUBLIC ADVOCACY FOR VOTER PROTECTION PROJECT

To make sure all eligible voters are heard on Election Day, the LWVUS has adopted five core areas of election administration reform being carried out through the **Public Advocacy for Voter Protection Project** and other national efforts. They are:

a.. Opposing ID and documentary proof-of-citizenship requirements

b.. Enhancing administration of statewide voter registration databases and guarding against wrongful or incorrect purging

- c.. Protecting voters against unnecessary restrictions on voter registration
- d.. Improving poll worker recruitment, training and supervision
- e.. Strengthening polling place management and ballot design

The Education Fund of the League of Women Voters of the United States along with the Leagues of Maryland, Virginia, and the National Capitol Area, have put together a Voters Guide for the Presidential Primaries. The guide is available from the internet at VOTE411.org.

The guide was compiled from written replies to questions from the candidates who met the League criteria before the publishing deadline. These include: Democrats Biden, Clinton, Edwards, Obama and Richardson and Republicans Giuliani, McCain, Paul, Tancredo, and Thompson. Candidates Dodd and Romney were invited to take part and chose not to.

There is one major hole in the Guide. Former Ark. Governor Huckabee is not included in the guide. He apparently did not meet the criteria when the Guide was being compiled. This is an example of how quickly things have changed in this presidential campaign. Nevertheless, the Guide contains some useful and interesting information on most of the current candidates. It is well worth a visit.

There is too much at stake in this election for citizens to sit back and not make their voices heard. The League is working tirelessly to ensure every eligible citizen can participate in this critical election year and make an informed decision on Election Day.

On January 19, 2008, the Immigration Committee met to take consensus. Commissioner Dave Fricke accepted our invitation to join us as we discussed the LWVUS Immigration Study Consensus Questions. Immigration Study Committee chair Susan McClure input our responses online to LWVUS by the February 1, 2008 deadline. Our league, along with hundreds of other leagues across the country, became a part of LWV history through the hard work of preparing for and holding a consensus meeting. The LWVUS will formulate an official position on immigration which will allow the entire organization to lobby and affect policy for years to come.

Thus ends a two year study to get grassroots agreement on a complicated issue. The same arduous process accounts for all of the positions from which the League lobbies every day. You can read the League's position statements at www.lwv.org.

Studying the issues and taking consensus to reach a unified position is one of the League's greatest strengths; as Susan says, it is the heart of the League.
