Voters in each school district in the state will be nominating and electing at least four school board members in the 2007 Primary (May) and General Elections (November). Anyone interested in running as a candidate or encouraging someone else to run, should consider attending a School Director Candidate Workshop on Saturday, January 20, 2007, from 8:30 a.m. to 5:00 p.m. at Rustic Lodge, Indiana, PA.

The workshop provides background in the responsibilities and issues of school directors and the requirements of candidates. The workshop will be presented by Ron Cowell, President of the Educational Policy and Leadership Center, Harrisburg, PA. EPLC has offered this workshop in the metropolitan areas of the state, but this session has been targeted for the West-Central area of the state, primarily the Routes 119 and 219 corridors, and will address concerns par-

ticular to rural areas.

The workshop is open to everyone interested in learning more about the work of school boards—potential candidates, future candidates, candidates' supporters, incumbents, and interested citizens.

The League of Women Voters of Indiana county, long known as a nonpartisan advocate for quality in public education, is the sponsor. The League believes that school boards are an important foundation of local government and are significant in the life of each community, both as policy makers for the lives of children, and as community employers.

Legislative Interviews

The remaining interviews will be held in February and are still being arranged. All interested League members are invited to attend.

The questions this year are on redistricting, election reform, health care and public transportation. The discussions are always lively and informative. It's a great way to talk to y our state legislators in depth about important issues. MERCURY REGULATIONS

The saga continues! The Governor announced that he was putting the regulations into effect shortly before the Legislature adjourned in November. The Legislature did not object and it looked like the stricter rules were on their way to taking effect. The next step was to publish the regulations in the Pennsylvania Register, a legally required step. The Legislative Reference Bureau, whose job it is to actually publish the Pennsylvania Register, has refused to publish the regulations. The LRB states that it is its opinion that the Legislature did not have enough time to consider the proposed regulations. This is quite unprecedented and the Governor is bringing his legal staff into the dispute.

Reflections on the IASD board meeting, January 8, 2007

The rumor mill was very effective at stirring up parents and bringing them to this meeting. Reaction to the Instruction Committee discussion of moving sixth grades into the junior high was way over the top. It is not helpful to assume negative decisions have been made without getting the full story.

Although everyone present supposedly was there because of concern for the education and welfare of the children of our community, this session was not a helpful model of public deliberation. Many of the behaviors exhibited by both board and audience members would not be acceptable in a school classroom. Listening skills were not in evidence. The audience seemed disinclined to hear board member statements claiming no decisions would be made without due deliberation and public input. Audience members sometimes scorned board member statements. Some board members reacted to audience comments in very confrontational ways as well. Roberts' Rules were ignored and the board chair had difficulty in keeping order.

What was lost in the midst of this parental uproar was the problem of how to find room for all-day kindergarten beginning in the fall of 2007. Early education specialists all seem to agree that all-day kindergarten is crucial in building reading and math skills in the early grades, yet no one addressed this concern at the meeting.

Most of the folks there were attending their first board meeting. Even in this out-of-control atmosphere it was good to see this large group of concerned parents. Perhaps we can make use of their "rumor mill" to encourage them to register to vote if they are not registered, and to vote in the May Primary election.

Comments made by some about informal discussions of school board matters among two or three board members seemed to come perilously close to breaking the intent of the state Sunshine Law which requires all decision-making to occur in public meetings. A minority of board members claim that two or three board members often meet to discuss board issues without the full knowledge of all.
