The Civic Participation Committee welcomes additional members as we make plans for the January 2011 workshop for potential candidates for school boards and municipal offices. The committee will begin planning in the early fall.

This workshop is a major contribution of the League to encouraging outstanding candidates and helping them understand the requirements for pursuing candidacy and helping them bring a board perspective to the roles they will be called to perform.

The election cycle in 2011 includes about half of the positions on seven school boards, at least one supervisor in each of 28 townships, and half of the positions on 14 borough councils, as well as some row offices at the county level.
