CIVIC PARTICIPATION WORKSHOP

The League of Women Voters will be holding a workshop for citizens interested in running for local office. It is scheduled for January 31, 2009 at the Rustic Lodge.

In 2009, citizens will be electing the majority of their local officials, most for 4 year terms. These will include: borough and township auditors, one magistrate, all borough mayors, half of all borough councils, 4 school directors in each district, 1 township supervisor in each township, tax collectors, the election officials who work at the polls and Republican and Democratic committee persons.

At the county level, we will be voting for a coroner, 1 Judge, 3 jury commissioners, the register & recorder and treasurer.

The League hopes to encourage more citizens to run for office and to become more involved in running their local government. Save the date.

NATIONAL STUDY ON THE ELECTORAL COLLEGE

At its convention this year the League of Women Voters of the United States approved a new national study as part of its program for 2009-10.

The focus of the study will be to determine if the Electoral College should be modified to more closely reflect the popular vote in Presidential elections. At the present time, the League has a position that the Constitution should be amended to remove the Electoral College provision and allow direct election of the President.

Online Voters Guide for state and federal level candidates: www.smartvoter.org. SmartVoter is a unique new on line Voter's Guide tool launched by local Leagues in Delaware County and the Greater Pittsburgh Area. For this election, voters in any part of the state can enter their address and zip code and view the offices and candidates that will be on their ballot in November and the wording of the Act 64 Water and Sever Improvements Bond Referendum. Most important, Smart Voter provides candidates with almost unlimited space to post biographical and other information about their candidacies including endorsements, and provide links to their campaign web site, email addresses, phone numbers and other contact information. Unlike our printed Voters Guides, the information candidates post on Smart Voter can be adapted to changing circumstances like the current economic crisis. Opposing candidates can also respond to each others positions on issues. Personal attacks are not permitted. As the campaign for President gets more intense, we all need someplace to go to find out the facts, or lack of them, behind election sound bites. These sites provide the best information we have found.

LWVPA asks General Assembly to address AFFORDABLE HEALTH CARE COVERAGE

The LWV of Pennsylvania recently wrote to Pennsylvania General Assembly members and asked them to address three issues before adjourning - redistricting reform, expansion of affordable health care insurance coverage to low income Pennsylvanians and energy savings legislation. Following is a synopsis of the health care coverage reforms that LWV is advocating:

An estimated 767,000 Pennsylvania adults lack health care insurance cover-

age more than the population of five states. A majority of the uninsured have full time jobs. The number of employed uninsured is growing as employers drop coverage because of rising costs that exceed the inflation rate. The League believes that all Pennsylvanians, indeed all U.S. citizens are entitled to a basic level of quality health care. One way to achieve that goal is to create a system of health care insurance that provides universal access.

Adults who do not qualify for government subsidies can buy into the program at a reasonable cost.

AdultBasic is currently funded by all state dollars. The House passed bill would authorize the Commonwealth to obtain a federal waiver on eligibility requirements for Medicaid funds so the federal government will pay 54 cents of every dollar spent on coverage, joining several other states that have already done so. This will allow us to cover choices most of us enjoy. Pennsylvania is on the verge of passing serious health care reform that could help grant access to quality health care and affordable health insurance for hundreds of thousands of Pennsylvanians and their families.
