LWVIC & Fair Districts to Host Draw the Lines Event

Fair Districts Indiana County in partnership with the League of Women Voters of Indiana County is hosting a Draw the Lines (DTL) event on Saturday, April 6 from 11:00 am to 2:00 pm in the Humanities & Social Sciences building (Room B11) on the IUP campus. This event is free and open to the public.

DTL is a rigorously nonpartisan organization with the goal of helping to foster a more public, transparent, accountable redistricting process that produces election maps voters can understand and trust.

Currently, in Pennsylvania and across the country, there is a push to end gerrymandering - the practice of dividing voting districts to give one party a majority in many districts while concentrating the voting strength of the other party into as few districts as possible. But every 10 years, voting districts are redrawn. The next time our voting districts will be redrawn will happen after the 2020 census.

Citizens are working now throughout the state to urge our legislators to pass legislation that would appoint an impartial, independent citizens commission to direct the redistricting process, and this DTL event will help to spread the word.

This event will engage and educate citizens about the redistricting process by providing attendees with the software and data they need to draw their own maps based on objective criteria like compactness as well as their own values and priorities. Attendees will also be encouraged to submit their maps to public mapping competitions which will be held by DTL twice a year through 2021. Cash prizes are given for the best maps drawn by high school and college students, as well as adult non-students.

DTL is an initiative to engage and educate citizens to prove to our elected officials that Pennsylvania citizens are ready, willing, and able to draw common sense political maps in a fair, transparent, and accountable process just like legislators should be able to do.

To learn more about this problem and its solution, please join the League and Fair Districts at this educational event.

Fair Districts is a nonpartisan, citizen-led, statewide coalition founded in part by the League of Women Voters of Pennsylvania working to create a process for redistricting that is transparent, impartial, and fair.
